Terms of Reference (ToR)

for

Partnership with Islamic Relief Bangladesh

Introduction: Islamic Relief Worldwide, an international development organization established in 1984, is
registered with the UK Charity Commission and holds consultative status with the UN Economic and Social
Council. As a member of prominent bodies such as the Consortium of British Humanitarian Agencies
(CBHA), Disaster Emergency Committee (DEC), European Confederation of Development and Relief NGOs
(CONCORD), and the International Red Cross and Red Crescent Movement, Islamic Relief is a globally
recognized leader in humanitarian work.

Islamic Relief Worldwide in Bangladesh (IRB) started its works in Bangladesh regardless of race, religion and gender and involved in nation-building since 1991. Islamic Relief seeks to promote sustainable economic and social empowerment by working with local communities in times of disasters as well as through development programs in the sectors of child rights, gender, water and sanitation, education, sustainable livelihoods, disaster risk reduction and climate change adaptation.

Islamic Relief Bangladesh invites national, regional, and local non-governmental organizations (NGOs) to submit Expressions of Interest (EoI) for potential partnerships. Shortlisted organizations will be evaluated based on criteria outlined in the detailed EoI guidelines and contacted for the next phase of the selection process.

2. Nature of Partnership:

IRB enters into a formal partnership agreement with selected NGO/s to directly implement the project without any further subcontracting. However, Financial commitments are made on a yearly basis depending upon funds availability and annual partner performance appraisal. The selected partners should be prepared to phase out in a short time notice in case of unavailability of funds at any point of time. The shortlisted NGOs will be kept on an active roster for future potential opportunities.

3. Eligibility Criteria for Submission of EoI:

To be eligible for consideration, interested NGOs must meet the following criteria:

- Legally registered NGO with relevant regulatory bodies (e.g., NGO Affairs Bureau, Department of Social Welfare, Ministry of Women and Children Affairs).
- Up-to-date certifications, including audit reports, tax clearance, and renewals.
- Minimum 5 years of proven experience in interventions integrated development programs.
- Experiecen in designing and implementing projects covering food security and livelihood (on farm and off farm), Water Sanitation and Hygiene (WASH), Women and Child Protection, Education, Health, Nutrition, Climate Change Adaption, Disaster Risk Reduction, Skill Development and Inclusion.
- Partnership networks with other organizations, community groups, and government agencies.
- Ability to mobilize and engage marginalized and vulnerable groups with grassroots presence.
- Qualified core staff for community work, technical support, financial management, and administration.
- Strong organizational structure and cost-efficient program management.
- Sound financial management, internal controls, and transparent budgeting.
- Regular audits and responsible financial record-keeping.
- Preference for organizations aligning with Islamic Relief Worldwide's values and demonstrating financial and technical competence.
- Strong ties with local communities and partnerships with community-based groups.



4. NGO Pre-Selection Process

The selection of partner NGOs for collaboration with Islamic Relief Bangladesh (IRB) will be conducted through a rigorous, impartial, and multi-phase process. The process ensures alignment with IRW's partner screening and due diligence guidelines and uses a standard selection framework and scoring matrix. Below is the structured pre-selection process:

- NGOs will submit an EOI, including all required documentation as per the detailed guidelines provided by IRB.
- 2. Shortlisted NGOs will undergo field visits for on-site verification.
- 3. A comprehensive financial capacity assessment will be conducted to evaluate financial stability, internal financial controls, and audit practices.
- 4. One-on-one meetings with shortlisted NGOs will be conducted to complete the full partner assessment, involving discussions on governance, strategic alignment, and operational capacity.

Based on the scores obtained during the selection phases, the selection panel will recommend potential NGOs for due diligence to the IRW headquarters. The final approval is contingent on the outcome of the screening and due diligence conducted by IRW headquarters. The entire process upholds impartiality and adherence to IRB policies and guidelines to ensure that the most suitable partner is selected.

Major Assessment Areas:

Key areas of assessment for the selection process include:

Experience and Expertise

- Demonstrated track record in development and humanitarian work, including experience with multiple donors.
- Proven ability to engage and work effectively in targeted districts with strong local community ties.

Organizational Governance and Management

- Evaluation of governance and management structures, including policies, roles, responsibilities, and inclusiveness.
- Assessment of gender equality and social inclusion (GESI) within the organizational structure and decision-making processes.

Technical and Financial Management

 Review of technical expertise, financial management practices, internal control systems, and efficient cost ratios between programmatic and operational expenses.

Strategic Compatibility

• Alignment of the organization's vision, mission, and objectives with those of IRW.

Verification and Documentation

- Interviews with key staff and board members, evidence review, and field visits for verification.
- Confirmation of valid registration with relevant authorities (e.g., NGOAB, Department of Social Service), including up-to-date tax clearance and renewal certificates.

The EOI must contain the following documents:

- a) A cover letter in official letter with signature & stamp.
- b) Duly filled EOI submission form with stated supporting documents.
